Cookies

We want to make our website easy, useful and reliable. Where services are delivered on the internet, this sometimes involves placing small amounts of information on your device, for example, computer or mobile phone. These include small files known as cookies. They cannot be used to identify you personally.

Run Amuk Cruises uses cookies to track aspects of your visit, to aid us in delivering personalised webpage content and navigation to facilitate the best possible user experience. We also use the cookies data to recognise you as a previous visitor to conveniently load relevant and saved information.

Google Analytics cookies on our site gather anonymous data such as geographic location, the method you used to reach this site, the length of your visit, the time of your visit, the pages that you visit and the keywords used to search while on the site. Personal Information
